According to the Centers for Disease Control and Prevention, one in three adults has not been screened for colorectal cancer as recommended. Fight Colorectal Cancer, a non-profit advocacy organization, will host the "80 percent in Every Community" Livestream event. The purpose of this event is to celebrate national achievements and contributions to addresses colorectal cancer. Presentations will also emphasize areas of opportunity to expand and improve colorectal cancer

screenings. This event will serve as a platform to launch Fight Colorectal Cancer's upcoming campaign to reach an 80 percent colorectal cancer screening rate nationwide.

Webinar: Mapping Lead Service Lines - Charting a Path to Engage a Community

Lead exposure can affect nearly every system in the body. Lead can enter drinking water when pipes and plumbing fixtures that contain lead corrode, especially where the water has high acidity or low mineral content. The Lead Service Line Replacement Collaborative (LSLRC) is an organization working to accelerate voluntary lead service line replacement in communities across the U.S. The LSLRC will soon host a webinar to explore how communities can map lead service lines, and discuss challenges to developing these maps.
